AWARENESS AFTER DFU

RAISING PATIENT AWARENESS



As healthcare professionals, it is imperative that we equip our patients who are seeking treatment for Diabetic Foot Ulcer (DFU) with adequate information to ensure their active involvement in the management of this condition (1,2). A multimodal approach including medical treatment, lifestyle adjustment, and patient education is required to address diabetes-related foot complications which are frequent and dangerous (3).

To reduce the danger of infection and ultimately amputation, DFU must be treated as soon as possible with proper and specialized care. Prompt treatment accelerated the healing of the ulcer, perhaps restoring foot function, and enhancing the patient's general quality of life (1,4,5). The proactive approach highlights the critical significance of early management in maintaining mobility (6). Actively engaging patients in their wound management would positively impact the DFU healing process reducing healing time significantly (5-7).

The guide below demonstrates 4 pivotal areas to emphasize when raising awareness and empowering patients about DFU management:

1. Prevention of Infection

Infection prevention is paramount in the care of DFUs. To avoid infections, patients should be instructed to practice meticulous hygiene (1,2). This includes avoiding being barefoot, particularly in outdoor or public areas where the risk of exposure to hazardous bacteria is high (3). Safeguarding the bandaged wound is of utmost importance to properly prevent infection. Patients should avoid wetting the bandaged area, as moisture can foster bacterial growth compromising healing process (7).

2. Blood Glucose Management

Effective management of blood glucose levels is crucial in DFU care. Maintaining blood glucose within the prescribed normal range is paramount for optimal wound healing and to prevent subsequent diabetes-related complications (8,9). Patients need to rigorously monitor their blood glucose levels and adhere to prescribed medication regimens. Routine tests should be followed up at specified intervals. These tests provide critical information about a patient's overall glycemic management and metabolic health (7,8).

3. "Off-Loading" the Pressure

In the management of DFU, off-loading pressure from the affected foot is instrumental. To reduce pressure on the wound site, patients should use crutches, braces, or specialized footgear (9,10). The goal is to minimize weightbearing on the affected foot, allowing the ulcer to heal effectively (1). Importantly, patients should avoid any impulse to expose the wound to the air by keeping it bandaged and cleanly dressed. This practice promotes a healing environment and prevents potential infections (11).

4. Regular Dressing

Adhering to a consistent wound dressing schedule is essential for effective DFU management. Patients should be advised to strictly follow the recommended wound care regimen, attend clinic appointments for professional care, and proactively participate in assessments (12,13). Compliance with healthcare specialists' advice and guidance on wound care would contribute significantly to healing processes (14). Patients should be encouraged to actively participate in clinical sessions, taking advantage to ask questions and learn more about managing diabetes best suited for their unique circumstances (3,13,14).

Empowering patients with vital pieces of information ensures better management of DFU with clinical better outcomes (1,2,3). This would in return result in better quality of life for the patient and their affected families.



IDF, IWGDF AND D-FOOT 2023 DIABETIC FOOT TRAINING

Rationale

As part of its 2021-2023 Collaboration Plan with the World Health Organization (WHO). the International Diabetes Federation (IDF) has to organize two capacity building trainings for healthcare professionals from and middle-income lowcountries (LMICs) on diabetic prevention and foot management.

2023 Diabetic Foot Training

In 2023, IDF will invite a number of healthcare professionals from LMICs with limited knowledge on the diabetic foot area to join the IDF 2023 Virtual Congress and follow the diabetic foot and neuropathy stream.

This 2023 training is supported by the International Working Group for Diabetes Foot (IWGDF) and D-Foot International.

Objectives

- Support WHO in strengthening capacity building and service delivery to reduce foot complications by training health care staff in line with WHO's recommendations for diabetes management.
- Facilitate access of healthcare professionals from LMICs to the IDF 2023 Virtual Congress.

Content of the 2023 Diabetic Foot Training

The 2023 Diabetic Foot Training is a comprehensive exploration of essential aspects of diabetic foot care. Covering global perspectives, it addresses societal roles, Charcot Foot updates, infection management, and the impact of

therapeutic interventions on neuropathy. From the intricacies of footwear in diabetic foot health to insights on pain management, sexual dysfunction, and the diagnosis of diabetic neuropathy, the training provides a thorough understanding. Healthcare professionals gain valuable knowledge on pathogenetic treatments, guidelines, and a holistic approach to diabetic foot care, making it an indispensable resource for enhancing patient outcomes.

Participants' Benefits

Participants will gain a nuanced understanding of neuropathy, encompassing somatic and autonomic manifestations. Emphasis is placed on early diagnosis through screening for preventing complications. The session delves into the pathophysiology of diabetic neuropathies, highlighting the absence of pathogenetic treatments and proposing various symptomatic treatments for painful neuropathy. A comprehensive insight into pathogenesis and prevention of diabetic foot issues will be offered, along with evidence-based treatments for DFU. The content extends to incorporating updated guidelines from the American Diabetes Association and the IWGDF into everyday clinical practice.

The 2023 Diabetic Foot Training has selected 30 delegates from Lowand Middle-Income Countries to occur on 5-7th December 2023. D-Foot is thrilled about ongoing collaborations with IDF and IWGDF, anticipating a future filled with innovative projects and impactful initiatives.

A 56-year-old male diagnosed with diabetes mellitus type 2 for 10 years, presented with ulceration of the lateral aspect of the 5th toe. The ulcer was 3cm by 2cm in size with punched-out edges.

Upon examination, the affected foot was warm and swollen with a good pedal pulse on both left and right. The patient's BMI was 25.3 kg/m2, random blood glucose 10.2 mmol/L, and blood pressure 142/84 mmHg. Currently, the patient is on metformin 500mg twice a day.

In assessing the patient's foot, what specific bedside examination techniques would you employ to further evaluate the presence of osteomyelitis, and how might these findings influence the management plan for the patient's diabetic foot ulcer?







The award will be presented every 4 years and for 3 consecutive editions during the ISDF meetings of 2023, 2027, and 2031. It is not intended as a small research grant but rather a resource to implement the IWGDF guidelines.

The planned budget is a "starting" budget and searching for additional sources is part of a successful sustainable project and is likely to be necessary.

More details will finally be announced in the next newsletter.
